Dear Mr. White & Mrs. Brady,

A group of your peers, five Health Career Agents Owner/Operators, have convened to discuss your violations of the agreement you entered into with Health Career Agents. They have voted to require that you discontinue making disparaging remarks, verbally or in writing, against Health Career Agents and its interests.

We insist that you immediately take down all disparaging remarks regarding the company and refrain from making such statements in the future. Failure to do so within 24 hours or at a minimum failure to acknowledge that a plan is in place to remove such remarks will result in the termination of your access to Health Career Agents resources until such time that you are in compliance with this provision of your contract.

You are still able to receive all deliverables under your agreement. As stated in your agreement you will need to contact our support staff directly if you have a candidate or a position to upload to the Global Database or if you require any training or support deliverables. As well, all Health Career Agents Member offices will be instructed to contact our support staff if they have a comparable candidate or position for you.

Please understand that we view this as a serious matter, one that we would like to remedy amicably and expeditiously without the necessity to take these, or additional, measures including legal action.
